BROKERS' APPOINTMENT FORM

By way of this Brokers' Appointment Form, with immediate effect we appoint Thomas Smith Insurance Brokers Ltd to act as our Insurance Brokers within the scope of the Insurance Brokers and Other Intermediaries Act 1998.

We also request that you assist us in the placing and administration of insurance covers and of any claims that we may submit in the course of your appointment. We request that any insurance supplier provides you with assistance and information as may be required, including information of any claims notified before or after this appointment. We also authorize you to collect outstanding claim proceeds due to us.

In addition this appointment provides our consent for Thomas Smith Insurance Brokers Ltd and/or its insurance brokers and/or authorized personnel at any insurance company, intermediary or surveyor or adjuster to process "personal or corporate data" provided that this processing relates to the underwriting or administering of insurance policies, the surveying, handling, adjusting and settling of claims, the keeping of statistics and the prevention and suppression of fraud, and as long as such processing complies with the Data Protection Act 2001.

Furthermore and specifically in relation to 'sensitive personal data' required for medical and life insurance policies we in addition authorize any doctor, hospital, laboratory or other health or life assurance provider or their service providers to provide full medical information and details concerning myself or my dependents provided this information is requested in accordance with the consent provided above.

We authorize you to keep me informed by mail, facsimile, e-mail or other electronic means, of your products and services, which you consider might be of interest to us. Should we wish to revoke this consent we will inform you accordingly. This appointment will remain valid until we advise you otherwise.
